



## Two Unidentified Suspects Sought in Armed Robbery Series; Surveillance Video Captures Both Suspects Pictures

Up to \$1,000 Reward Offered

San Diego County Crime Stoppers and detectives from the San Diego Police Department's Robbery Unit are asking for assistance from the public in identifying two suspects wanted for a robbery series in San Diego.

*Between August 25 and September 10, 2010, an unknown male and female suspect robbed five businesses, four in City Heights and one in Hillcrest. In all five robberies, the male suspect displayed a handgun at the clerk and demanded cash from the register. No one has been hurt in the robberies. A surveillance camera captured pictures of both suspects; **pictures of the suspects are attached to page two of this release.***

### **Suspect Descriptions:**

- 1) *Black male, between 20-30 years old, approximately 6'0"-6'1" tall, thin build, black eyes and brown hair.*
- 2) *Black female, between 18-25 years old, approximately 5'1"-5'5" tall and medium build.*

### **Robbery Locations:**

- 1) *Jack in the Box, 804 University Avenue (Robbery occurred on 8/25/2010.)*
- 2) *Burger King, 4144 University Avenue (Robbery occurred on 8/27/2010.)*
- 3) *Little Cesar's, 4128 University Avenue (Robbery occurred on 9/01/2010.)*
- 4) *Subway, 4151 El Cajon Blvd. (Robbery occurred on 9/08/2010.)*
- 5) *Cricket Wireless, 3648 University Avenue (Robbery occurred on 9/10/2010.)*

Detectives are asking anyone with information on the identity and or location of the persons responsible for this crime to call the **Crime Stoppers anonymous tip line at (888) 580-8477**.
